#### Terms & Conditions for Dumpster Container Usage:

## Dumpsters are for C&D Debris Only! Mixed items found in containers may be left on site until removed and/or are subject to addt'l fees.

- 1 ABSOLUTELY NO Liquids, Hazardous/Toxic Waste, Motor Oils, Paints, Solvents, Insecticides, Explosives, Batteries, Tires, Light bulbs etc.
- 2 ABSOLUTELY NO Concrete Slurry to be loaded into the 10-Yard Low Boy.
- 3 Maximum weight limit as follow 40-Yard dumpster 6 Ton Limit, 10-Yard dumpster 10 Ton Limit, 1-Yard dumpster 240lbs limit.
- 4 Mixed items that are not considered C&D debris that are found in container upon arrival are subject to an addt'l handling fee to Customer.
- 5 It is the responsibility of the contractor to indicate the location on which the Dumpster is to be placed.
- 6 It is the client's responsibility to ensure area where dumpster is to be placed free and clear of obstruction i.e., path of travel, parked cars etc.
- 7 I.R.S. Demo will not be responsible for any damage to asphalt, concrete, driveways & walkways, etc. caused by truck or container.
- 8 Protection for path of travel is not included in container services, unless previously arranged for in advance, at an additional fee.
- 9 Customer is responsible for safe keeping of container(s) while in their possession. Customer will be responsible for any/all cost's for repairs, damage and/or stolen containers while in their possession.



- 10 Customer is responsible for any damage caused by fire, theft, negligence, abuse or vandalism and agrees to pay all costs and expenses necessary to restore or replace said equipment. Customer is aware that the damage may occur to the surface where the container is placed (loaded or unloaded) and where the truck may crossover. Therefore, customer directs the placement of the container and agrees to save company harmless from any damages, which may result thereof.
- 11 Containers should not be filled higher than the top line of container or exceed the maximum weight limits as listed above.
- 12 If container exceeds weight or fill level and/or box is deemed unsafe it will not be hauled until the excess debris is removed. and will require additional scheduling. Dry run charges will apply.
- 13 Customer is RESPONSIBLE for citations issued for overweight fee's and/or unlawful parking due to customer request.
- 14 Concrete or dirt is allowed in Lowboy containers only.
- 15 I.R.S. Demo crew members are not allowed to enter any building at any time.
- 16 It is the customers responsibility to retrieve 1-yard bins from a marked loading/unloading designated area outside of building.
- 17 Customer must notify IRS Demo at time of order if dumpster will remain on premises for more than 14 days. Addt'l Fees may apply. **Payment Terms - Credit card Authorization form must be completed and provided to IRS Demo Prior to services rendered** Charges for service are processed prior to actual services rendered, with any additional fee's incurred processed immediately thereafter including but not limited to - overweight fee's, City Hauling fee's, special handling fee's, stand by time etc.
- 18 Invoices for Dumpster services are provided within three days of service and are provided along with copy of Credit Card payment receipt.
- 19 Invoices are issued on a site-by-site basis for all transactions during the current invoice time frame.

It is the responsibility of the customer to provide any necessary reference number and/or information (i.e., Job name/number or PO #) that customer requires to be referenced on customer invoice AT THE TIME OF PLACING ORDER with I.R.S. Demo Dispatch Dept. \*If multiple jobs are running concurrently at one location, and Customer requires separate invoices (for in-house tracking purposes) Customer must notify dispatch - AT THE TIME OF ORDER.

\* If Customer Ref/Job # changes during the course of service - you must notify Dispatch AT THE TIME OF PLACING ORDER.

IRS Demo has no means by which to track and/or monitor such customer reference information and will not be held liable for incorrect and/or missing information. Once an order has been placed and dispatched, Invoices cannot be modified due to incorrect Cust. Ref info.


